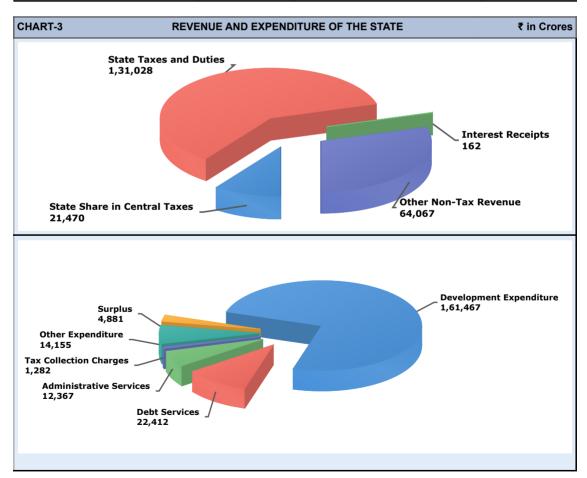

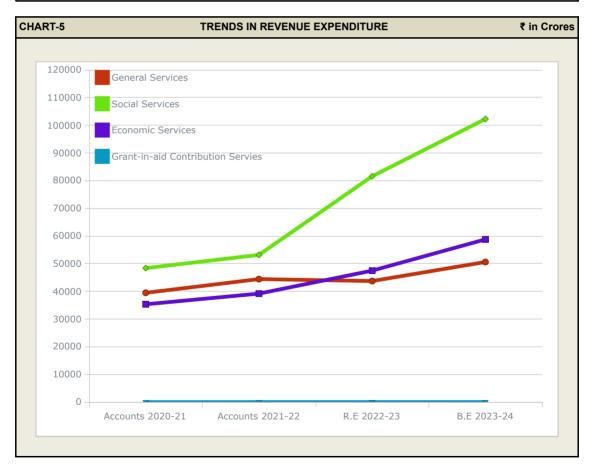

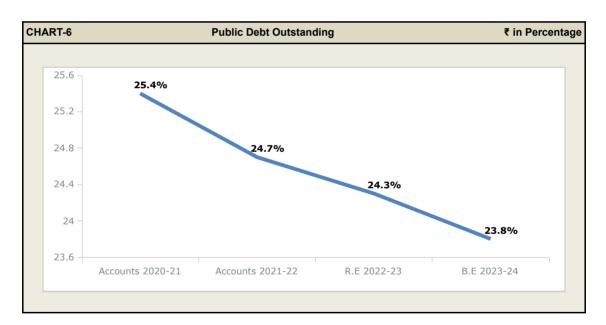

Public Debt Outstanding

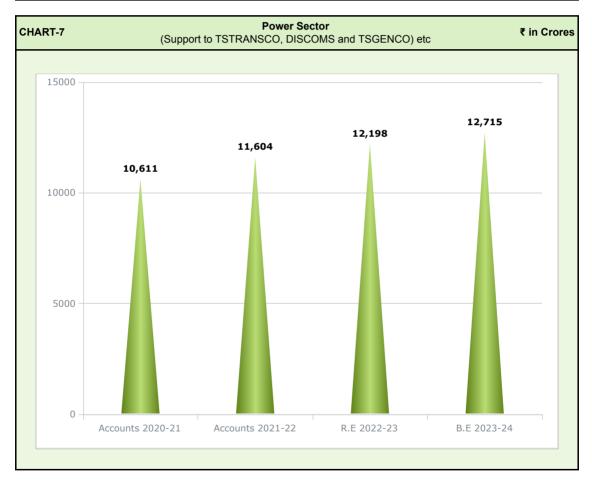

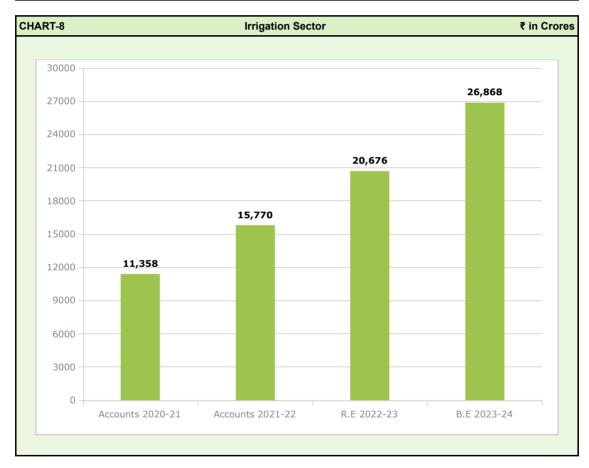
